

**BSR Franchising Pty Ltd
Win a Brisbane Fridge
Terms and Conditions**

1. Information on how to enter forms part of the terms of entry. Entry into the competition is deemed acceptance of these terms and conditions.
2. Entry is open to all residents of Australia. However, employees and their immediate families of BSR Franchising Pty Ltd and its related body corporate, entities operating retail stores which are associated with BSR Franchising Pty Ltd and their associated agencies and companies are not eligible to enter.
3. The competition commences on Saturday 19 December 2015 at 12:00 pm AEDT and concludes on Sunday 8 January 2016 at 23:59 AEDT.
4. The competition will be advertised in print media, online at Betta.com.au and at the Brisbane Cricket Ground.
5. To enter, participants must attend the Promoter's stand at the Main Street entry Brisbane Cricket Ground, and complete an entry form on the iPad, Tablet or Laptop provided.
